1. All testimony, information, documents, writings and things provided by a party to this action in response to any discovery in this action and designated confidential by the providing party, together with all notes, summaries, extracts or other information derived by me or by others from such materials (the "Confidential Information"), shall be held and used by me only as necessary for the prosecution of this action and shall not be held or used by me for any other purpose.

2. I shall not divulge, disclose, share or make available Confidential Information or opinions based on Confidential Information to any person firm or entity other than the counsel who has provided the Confidential Information to me.

3. I shall take all appropriate and necessary measures to prevent the inadvertent disclosure of Confidential Information or of opinions based on Confidential Information to any other person.



4. Within ten days of the conclusion of this action, whether by judgment or settlement, or upon termination of my status as a person entitled to receive Confidential Information pursuant to the Protective Order, I shall promptly return all Confidential Information and opinions based upon Confidential Information in my possession (including all copies, extracts and/or summaries thereof) to counsel who provided the Confidential Information to me. I will retain no copies of any of the above.

5. All restrictions on the disclosure of Confidential Information and of opinions based on Confidential Information shall remain in effect and be binding on me after the conclusion of this action.

This Agreed Protective Order is entered pursuant to Rule 26(c) of the Rules of Civil Procedure upon the agreement of Plaintiff Robert Snapp ("Plaintiff") and Defendant Tandy Corporation ("Tandy") by and through their respective counsel. It is hereby ORDERED:

1. All testimony, information, documents, writings and things provided by any party in response to any discovery in this action and designated confidential by the providing party together with all notes, summaries extracts, or other information derived from such materials (the "Confidential Information"), are and will remain confidential and private.

2. The Confidential Information may be held and used only by counsel for the recipient and only as necessary for the prosecution of this action.

3. Counsel for the recipient shall not divulge, disclose, share or make available to any person, firm or entity any Confidential Information in any form, except as provided in paragraph 4.

4. Counsel for the recipient may disclose Confidential Information to the client and to the client's trial experts, but only to the extent necessary for the prosecution of this action. In this connection, the client and the client's trial experts may hold and use the Confidential Information only as necessary for the prosecution of this action, and shall not divulge, disclose, share or make available to any person, firm or entity any Confidential Information.

5. Before disclosing Confidential Information to the client or the client's trial experts, (1) counsel shall provide them with a copy of this order to ensure that it is not inadvertently violated, and (2) counsel shall ensure that the client and the client's trial experts agree in writing in the form of Exhibit A attached hereto to be bound by this agreed order.

6. Within ten days of the conclusion of this action, whether by judgment or settlement, all Confidential Information shall be returned to the providing party or destroyed, without retention of copies.

7. In the event that a party wishes to use any Confidential Information in this action, the Confidential Information and any document (including without limitation any pleading, motion or memorandum containing Confidential Information) shall be filed under seal and maintained under seal by the court.

8. All restrictions on the disclosure of Confidential Information and opinions based on Confidential Information shall remain in effect and be binding on all parties after the conclusion of this action.
